

Working with Dementia Network

Their vision is to create a collaborative research network that supports and develops innovative ways to improve the working lives of people affected by dementia. Lyndsey is working alongside Professor Valerie Egdell from the Business School and Professor Arlene Astell from the Psychology Department, in collaboration with academics from the University of West Scotland, Wilfred Laurier University, Warwick University, Lancaster University, and Edinburgh Napier University on this network.



UK Public Attitudes to National Security Data Processing

A Centre for Emerging Technology and Security report titled "UK Public Attitudes to National Security Data Processing: Assessing Human and Machine Intrusion" co-authored by Marion Oswald, was published in May. It was launched at the CETaS annual showcase on at a panel chaired by Sir Brian Leveson (the Investigatory Powers Commissioner). The findings are based on both a national survey and an in-person citizen's panel, and draw conclusions about the public's support for different types of national security data processing, knowledge and support for national security oversight processes, and the public's views on human vs machine data processing.

13 yards off the big gate and 37 yards up the West Walls

Helen Rutherford's research was quoted in 'Forensic Science in England and Wales: Pulling Out of the Graveyard Spiral'. The research carried out by Helen and Clare Sandford-Couch (Leeds Law School) "13 yards off the big gate and 37 yards up the West Walls". Crime scene investigation in mid-nineteenth century Newcastle-upon-Tyne.' was quoted in The Report of the All Party Parliamentary Group on Miscarriages of Justice- Westminster Commission on Forensic Science: Forensic Science in England and Wales: Pulling Out of the Graveyard Spiral'.

This research showed that Newcastle-upon-Tyne police in the early to mid-nineteenth century indicates a methodical, arguably scientific, approach to crime scene analysis.

Through their efforts they were able to bring their research to diplomats involved in space diplomacy and international space law.

Northumbria university recently released the SLO annual report or 2024/2025. which highlights the fantastic work and achievements of the clinic over the past year.


In the last academic year, the SLO welcomed 196 students, accepted 267 cases and donated over £308,000 worth of legal services to the local community! The statistics show the hard work and dedication from the law office staff and students, and it is expected that next year will be ever busier, with a confirmed increase in students enrolled for 2025-2026.



SLO Students Present Findings to Amnesty International

The Student Law Office Policy Clinic held a roundtable discussion, lead by Lars Waldorf, to present findings from its report for Amnesty International on "Resisting Hate: Youth and Community Resistance to the August 2024 Racist Riots in Northeast England.". The report documents stories of students, youth, and community members in Newcastle and Middlesbrough who took part in a range of anti-racist, anti-Islamophobic, and anti-xenophobic resistance – from solidarity demonstrations to protecting at-risk youth to cleaning up after riots. The report is part of Amnesty International's wider Civic Space Fellowship, which aims to amplify strategies to resist illiberalism and shrinking civic space around the globe.
