Over the past months the team have been invited again to a number of prestigious events and won important grants:

- **Professor Matt Baillie Smith** has been appointed to the advisory board for the final evaluation of Voluntary Service Overseas' Department for International Development funded International Citizen Service

After two and half years at the Embassy, I decided to become a civil servant, and in 2016 I won a placement as Officer at the Department of International Organizations, Ministry of Foreign Affairs. The work at the Ministry has been a very interesting experience. I realized how little I knew and understood about development work. In 2017, I decided to further my studies, and I have been awarded a UK government Chevening Scholarship for the academic year 2017/2018 to do a Master's degree at Northumbria University. The course has been a very enriching and engaging learning experience for me. The diversity of the class and the modules make the learning experience even more worthwhile.



Major research reviews for policy makers

Dr Sarah Coulthard conducted a review of research conducted over the last 10 years funded by the ESPA (Ecosystem Services and Poverty Alleviation) programme. The review assessed the extent to which ESPA research had engaged with multidimensional concepts of poverty and wellbeing to understand how ecosystem services can contribute to poverty reduction. Sarah presented the results at the annual science conference in Edinburgh in December 2017 and attended a 2 day policy workshop to distill key messages for policy makers from the ESPA programme overall. The review is being published as a book chapter in the ESPA synthesis book out soon.

- **Professor Baillie Smith** and **Dr Nisha Thomas** co-facilitated a global research conference on Volunteers in Conflicts and Emergencies with the Swedish Red Cross, in Stockholm in December 2018. The event was part of the joint Volunteering in Conflicts and Emergencies Initiative, and attracted leading and humanitarian and development actors, including NGOs, the UN and ICRC

- Exhibition for International Women's Day, 5th May 2018: As part of **Katy Jenkins'** Leverhulme Fellowship, she organised an exhibition in Cajamarca, Peru, of photos taken by women anti-mining activists on what 'Development' means to them in the context of living with large scale resource extraction. Katy appeared on a local TV news programme in Cajamarca and on several radio shows discussing the project and the exhibition.
- **Dr Mark Griffiths** ran a session in April at the Annual Meeting of the American Association of Geographers in New Orleans on The Body, Political Violence and the Colonial Present. He also gave a paper on Biopolitics and Checkpoint 300 in Occupied Palestine: bodies, affect, discipline.
