## Welcome to the Student Law Office

I am extremely proud of the work and achievements of the Student Law Office, and this report illustrates the wide range of activity undertaken, from representing clients to disseminating best practice through research and scholarly activity.

At the heart of the Student Law Office are our students, and the opportunity for a transformative learning experience. But we also hope to expose students to the real need for access to justice, and this combination is what makes the Student Law Office a model of university community engagement, where students learn through serving others. This year saw the development of an exciting new project, Gateshead Advice Project (GAP) providing an advice clinic in partnership with Gateshead Citizens Advice Bureau. These projects help to expand the availability of legal advice to groups who may otherwise struggle to access this.

Last year we were delighted to receive the ultimate accolade through being awarded the Queens Anniversary Prize for the exceptional work of the Student Law Office to add to the panoply of other awards achieved. This year, the Student Law Office was shortlisted for the Northern Law Awards as well as the Namati Justice Prize. These awards reflect the efforts of staff and students in offering a legal service to the community. I was also delighted to support SLO students in running a student –led conference on pro bono and clinic. This attracted guests from all over the country, and was a highly successful event.

We have continued to be active on the international stage. Our 13th IJCLE conference this year was in Turkey, partnering with Global Alliance for Justice Education, and was a great success. The move to the IJCLE becoming an open access journal has provided a focal point for the dissemination of research on clinic, and the new Legal Education and Professional Skills Research Group (LEAPS) has been led by clinic staff, and has hosted some excellent sessions.

My heartfelt thanks to staff, students and our legal partners for their support of the Student Law Office, and I look forward to another successful year.

### About the Student Law Office

#### What is the Student Law Office?

The Student Law Office (SLO) is Northumbria Law School's multi award-winning pro bono law clinic where students, under the supervision of qualified staff, offer a full legal service to members of the public. We are proud of the contribution made by the SLO to the local community, offering free advice and assistance to many who could not otherwise afford this. The clinic is a key part of our innovative four year MLaw degree course which integrates the professional skills of the Legal Practice Course into the new Masters level degree. Students take on real cases and provide a full legal service, conducting interviews, researching, advising, drafting and, in suitable cases, providing representation. Their work is closely supervised, but normally all client contact is through the students.

## What preparation do students have before entering the Student Law Office?

Students take part in an SLO program in Year 3, where they practice interviewing clients and develop an awareness of the office systems and their own professional responsibilities. In Year 4, they join the live client program, and this accounts for around 40% of their final year mark. Assessment is by means of a personal file, which is a portfolio of the work they have completed during the year, in addition to two reflective pieces, looking back at their own development during the year.

#### What about Legal Practice Course skills?

Students are assessed for competence in writing and interviewing as part of the Legal Practice Course during their time in the SLO.

## Who else can take part in the Student Law Office?

The SLO experience is also available as an option on the full time Legal Practice Course and the Bar Professional Training Course, although places are limited.

#### Legal Advice Byker shortlisted for inaugural Namati Justice Prize

Our Legal Advice Byker project was shortlisted for the inaugural Namati Justice Prize, a prestigious legal empowerment honour.

The accolade recognises 'grassroots' justice and legal empowerment projects, and great deeds in legal empowerment, which give people the power to understand and use the law to secure justice and meet basic needs.

Legal Advice Byker provides legal advice and guidance to disadvantaged individuals and families across the Byker area. Since its inception in 2012, it has offered its support to almost 100 vulnerable members of the community – a large number of whom would not normally have access to legal advice elsewhere.

Namati Justice Prize judges looked for projects that have had an extraordinary impact on people's lives, that have the potential to grow in scale, and that deliver justice in the face of great difficulties.

#### Carol Boothby, our director, said:

"Legal Advice Byker has really captured the imagination of the community – it's a service for people who believe they have no power or means to address their legal issue and who feel they have nowhere else to go.

#### Northern Law Awards 2015: Pro bono/ Community Initiative and Law Teacher of the Year

We were delighted to be shortlisted alongside some of the biggest legal names in the North East in the Pro Bono/Community Initiative category at The Northern Law Awards 2015. These awards celebrate the legal talent and success within the region.

Our director, Carol Boothby, said: "To be shortlisted in the Northern Law Awards 2015 is a tremendous achievement for the Student Law Office here at Northumbria University.

"The awards recognise the best of the best in the North East's legal sector and to be considered alongside top firms is a huge boost for all involved, and is testament to the invaluable service being offered to the public by our students." Carol added: "The students provide a lifeline for many people in Newcastle who simply can't afford legal representation. To have this work recognised yet again demonstrates how important the work of the Student Law Office is to the local community."

Carol was also nominated for the prestigious Law Teacher of the Year Award, which recognises innovative teaching practices and an ability to enhance the student learning experience through scholarly activities. Many congratulations to Carol, and likewise fellow Northumbria Law School lecturer Richard Glancey who was also nominated.

#### SLO students commended by Assistant Coroner



### **Our Community Projects**

#### **Gateshead Advice Plus (GAP)**

The GAP project ran as a pilot this year for a 6 week period from 11th February 2015 until 18th March 2015. It was run in conjunction with Gateshead Advice Centre (CAB) and offered advice in Housing and Benefit issues. The students had an hour with each client split into three 20 minute slots. The first to take instructions, the second to discuss advice with their supervisor and the third to give advice to the client with the supervisor present. This was then followed up with a full advice letter within a three week period. In this short period, we had appointments arranged with 11 Housing clients and 12 Benefit clients.

#### Legal Advice Byker

Launched in February 2012, the project includes students and staff from Northumbria Law School and staff from leading legal aid law firm Ben Hoare Bell. From February to May each year, students studying on Northumbria's Legal Practice Course offer free one-off advice to members of the public. This is Legal Advice Byker's fourth consecutive year, and the total number of clients seen to date has reached 100. If you are aware of someone who thinks that they might need legal help and who wants some initial advice before going further, then we will start taking enquiries at the end of January 2016.

National Pro Bono week – success again for "Law in the Library"

In November 2014, as part of National Pro Bono Week, the SLO and the LawWorks North East Pro Bono Hub provided a number of drop-in sessions at Newcastle City Library. Members of the public were able to drop into the library and receive advice or referrals from qualified solicitors on a range of legal areas including consumer disputes, housing, family and business. National Pro Bono week activities are led by Solicitor Tutor, Paul McKeown, who said: "Law in the Library continues to be a successful event facilitating access to free legal advice to members the local community on a range of legal issues. The partnership with Newcastle City Library means that the service can be delivered to those who may not ordinarily be able to access legal advice."

#### Shelter

For the last 7 years, we have run a joint project with Shelter, with students researching and advising clients on more complex housing queries, whilst gaining invaluable experience in the area of housing law. We dealt with 23 housing enquiries during this year through this scheme.

## **Clinical Research**

#### LEAPS: Legal Education And Professional Skills research group

The group is an inclusive collegiate group intended to provide support, promote and enhance legal education at Northumbria. The group acts as a focus point for research activity surrounding legal education and professional skills.

There is a well-established history of research into clinic with the Law School publishing its own International Journal of Clinical Legal Education and hosting an annual conference. A number of members are on editorial boards of legal education journals. Many SLO supervisors are members of LEAPS.

This year, LEAPS has held a number of successful events. They include guest lectures from Professor Andrew Francis and Professor Fiona Cownie, both of Keele University. The LEAPS group also held "Problematising Assessment in Clinical Legal Education" in June 2015. This interactive seminar and discussion forum centered on one day conference explored the theme of how experiential learning in law is assessed. Funded by the Association of Law Teachers, this event was a resounding success.


