Argentina's disappeared: separating the body and the name

Border crossings into the EU: land, air and sea: Definitions of the human and production of subjetivities at stake.



Moving from one territorial sovereign to another through the border, "the sovereign authority to include or to exile and the sovereign responsibility to protect become disconnected, in all these moments of rupture, the suture of sovereignty is revealed."

"The border-crossing subject stiches him/herself into the narrative of belonging, so too does the sovereign state incorporate the subject as a border-crosser than can be accepted or rejected, defining what populations can move."




Self made prosthetic artefacts as body enhancement in order to jump the fence.


Sea borders: Greel-Turkish maritime border

Air borders: biometric controls in airports



Paper documentation is replaced by algorithmic translations of information captured from the body.

Physiologic biometrics

Biometrics

- Registers individual physical markers
- Seeks to establish an identity: Who is he/she?
- Verification and autentification: ¿Is this the person he/she claims to be?
- Needs physical contact
- There is knowledge and there can be consent.

- Fingerprints, face or iris recognition, hand geometry, DNA.

Behavioural biometrics

Behaviometrics

- It is based on behavioural patterns
- Aims at predicting behaviour
- Establishes profiles.
- Operates at distance and hidden.
- Does not need explicit cooperation.
 There is no knowledge and no consent.
- Geit, walk, hearbeat, temperature.






