## Nursing Placement Information - 2024/25

We at Northumbria University value the student placement support that we receive from our practice partners in the private, voluntary and independent placement areas.
Facilitation of student nurse placements from our partners provides excellent and valued learning for our student nurses in the clinical and home environments which are part of statutory requirements for nurse education and subsequent registration.

Northumbria University values the new curriculum which significantly contributes to a nursing workforce that is fit for purpose in the future.
The future workforce is dependent on placement opportunities, and this is where we value your continued support.

## Practice Placement and University Experience

Under the new curriculum, for most of their programme, students spend 3 days in practice and 2 days in university. (22.5hrs/week)

Placements are between 09-12-week placements where the student can be a valued team member in a supernumery capacity.
Student learning can be facilitated with all team members and the wider multi professional team.
Longer placements provide continuity and an excellent opportunity for students to progress through proficiencies with various levels of supervision.

We value the opportunity for our students to attend home visits while on placement. This enables students to meet the EU Directive to attend a designated number of home visit learning experiences.

Practice areas can benefit from Northumbria University Partnerships within their monitoring and governance requirements by the involvement of teaching and assessing students.
Supporting students evidences a research rich practice area and supports our registered nurse practitioners to address their statutory Code of Practice to support learners.

## When will students attend?

Primary care placements have evaluated extremely well and remain central to the students' learning experiences. There are several opportunities across the year for you to be able to support our students and these are outlined below. We are currently requesting offers for the placements highlighted in yellow.
