Promote peaceful and inclusive societies for sustainable development, provide access to justice for all and build effective, accountable and inclusive institutions at all levels.

An Overview

We are living in a world that is increasingly divided. Some regions enjoy sustained levels of peace, security and prosperity, while others fall into seemingly endless cycles of conflict and violence with millions impacts by homicide, violence against children, human trafficking, sexual violence, poor access to justice and corrupt organisations.

Every individual has the right to be legally recognised and protected. 73% of births globally are registered, but this level is as low as 46% in some areas of Sub-Saharan Africa.

Justice must be provided for all yet the proportion of prisoners held in detention without sentencing has remained almost constant in the last decade, at 31% of all prisoners.

Corruption, bribery, theft and tax evasion cost around US \$1.26 trillion for developing countries per year; this amount of money could be used to lift those who are living on less than \$1.25 a day above \$1.25 for at least six years. Among the institutions most affected by corruption are the judiciary and police.

50% of the world's children experience violence every year. Every 5 minutes, somewhere in the world, a child is killed by violence. 1 in 10 children is sexually abused before the age of 18, and 732 million children do not have legal protection. 246 million children worldwide are affected by school-related violence each year and 1 in 3 students has been bullied by their peers at school in the last month, and at least 1 in 10 children have experienced cyberbullying. Child online sexual abuse reports to NCMEC grew from 1 million in 2014 to 45 million in 2018.

The objective of SDG 16 is to significantly reduce all forms of violence, and work with governments and communities to find lasting solutions to conflict, corruption and insecurity. Strengthening the rule of law and promoting human rights is crucial to this process, as is reducing the flow of illicit arms and strengthening the participation of developing countries in the institutions of global governance.
